The candidates included in the Provisional rank lists have **no claim unless the eligibility conditions are satisfied on physical verification of documents/certificates and subject to availability of seats (As per Notification).**

The candidates included in the Provisional rank list for the B Tech. Agricultural Engineering programme at Kerala Agricultural University for the Academic Year 2024-25 are hereby directed to **report in person** on the date, time and venue mentioned along with the following original documents.

1. Proof of Date of Birth - High school/Class X/Matriculation Certificate.
2. All Certificates and Mark sheets /Grade reports, related to Class X and Class XII.
3. KEAM/ CUET Rank Card / Score card and Candidate's Data sheet (showing the Rank of the Candidate) from the concerned Authority.
4. Physical Fitness Certificate issued by Medical Officer not below the rank of an Assistant Surgeon.
5. Non-Creamy Layer Certificate (NCLC) in case of reservation candidates under SEBC (Ezhavas, Muslims, OBH, LC/AI, Dheevara, Viswakarma, Other Backward Christians etc.)
6. Community Certificate (for SC/ST candidates)
7. Income and Asset Certificate (for EWS Candidates) (original)
8. Medical certificate issued by the competent authority in the case of Differently Abled (DA) candidates.

9. Character/ Conduct Certificate (original) from the Head of the Institution last studied.
10. Original Transfer Certificate (**to be submitted within 3 working days, only after confirming admission**)
11. Migration certificate (original)
12. Aadhaar Card
13. Nativity Certificate

* Candidates are directed to keep sufficient photocopies of each certificate mentioned above with them at the time of admission.

* Admission fee as specified in the Prospectus of the related course is to be remitted by all the candidates at the time of admission. (**Fee is collected by UPI/QR code**) at KAU HQ.

* The semester fee is to be remitted at the allotted institution at the time of registration of semester.

* Candidates who fail to report in person for admission along with the documents as specified above or fail to remit the admission fee at the time of admission will lose their chance for admission without assigning any reason or any further notice.

*In such cases, next eligible candidates from the list will be given admission according to the rank and the reservation. No further claim in this regard will be entertained.
