Nationality & Age Limit:

The candidate must be a citizen of India and shall not be over 40 years age as on 01.01.2024. Age relaxation as per existing Government rules will be granted to eligible candidates. All other conditions are as per Kerala Agricultural University norms.

The candidates should attend the selection process & interview scheduled to be conducted on 10/10/2024, Certificate Verification will start at 9.30 AM and the interview will be conducted at 10.30 AM onwards. Candidate should bring all relevant documents & certificates and reach the office of the Krishi Vigyan Kendra – Kottayam, Kavanattinkara, Kumarakom, Kottayam in time.
