Sub: - Referendum for the purpose of recognition of service organisations of non-teaching staff of the Kerala Agricultural University - Election notification published - Reg.

Whereas it has become necessary to conduct a referendum for the purpose of recognition of service organisations of non-teaching staff of the University in compliance of the Judgment dated 11/01/2019 of Hon. High Court of Kerala in WP(C) No.2630/2018, it is hereby notified that an election by secret ballot in the prescribed manner will be held for determining the number of members for the purpose of recognition of service organisations of non-teaching staff of the University.

Details of Polling Stations, Polling areas, Electoral Roll Numbers of electors to vote at the station etc. will be published sooner.

Only those whose names have been included in the electoral roll as published by the University on 27/11/2019 and corrections issued up to 23/12/2019 are eligible to take part in the Referendum and vote thereof, provided that any person who ceases to be a member of the electoral body before the date of poll shall not be entitled to participate in the Election.

Copies of the electoral rolls can be downloaded from the University website [www.kau.in/referendum](http://www.kau.in/referendum). Every elector is at liberty to propose an association for participation in the referendum. Every nomination shall be in writing and shall be supported in writing by not less than 10 other electors included in the electoral roll. The name proposed for such association shall be specified by the elector proposing the nomination. Nomination should be made in prescribed form, copies of which will be supplied on request from the office of the Registrar & Returning Officer.

The envelope containing nomination paper shall be superscribed: "Nomination of Association for participation in the Referendum".

The proposer and one nominee authorized by the proposer in writing with the approval of the Returning Officer can be present at the venue of scrutiny of nomination.
