The cost of tender form is Rs.0.20% of the tender amount (rounded to nearest 100/-, minimum Rs.400/- and a maximum of Rs.1500 + GST as applicable). A DD for the amount drawn in favour of the Professor and Head, CRS, Pampadumpara, payable at SBI, Nedumkandam, should be enclosed along with the tender submitted.
2. Earnest Money Deposit (EMD) @ 1% of the cost of items offered may be remitted by a

separate DD drawn as detailed above. Firms who are exempted from payment of EMD should furnish copy of the currently valid certificate from the Store Purchase Department, Govt. of Kerala. The format can be downloaded from the above website.

3. The tender should be accompanied by an agreement in Kerala Stamp Paper worth Rs.200/- (Rupees Two Hundred only) and format can be downloaded from the above website.
4. Successful tenderers will have to execute an agreement on Kerala Stamp paper for Rs.200/- and remit security deposit @ 5% of the tender amount accepted by means of DD. Form of agreement can be downloaded from the website <http://www.kau.in/tenders> under the Related Documents section.
5. The exact specification, details of made, model, name of manufacturer, warranty details etc., of the item must be clearly specified.
6. The tender should be in the sealed cover and to reach the undersigned on or before **17<sup>th</sup> February 2023 at 2.00 pm**. Tenders received late or incomplete in any respect will be summarily rejected without notice and the decision of the undersigned on such matters will be final.
7. The tenders will be opened at **2.30 pm** on the same day in the presence of those who are present at that time. The lowest rate will be accepted if reasonable.
8. The sealed cover containing the tender documents should be superscribed "**Tender for the supply of Clevenger Apparatus and Soxhlet Apparatus including multi position heating mantle**" and sent to the Professor and Head, CRS, Pampadumpara, PIN 685 553
9. The rate quoted should be inclusive of all charges including GST, if any and also connected expenses, if any.
10. The item should be supplied within 3 weeks from the date of receipt of supply order.
11. The supplier should give the details of the nearest service center and response time. Complete descriptions specifications and make of the good should be given in the quotations. Leaflets/brochures/catalogue of the equipments describing its features, application/specification etc. should be provided along with the tender.
12. Details of warranty after sale service offered on expiry of normal warranty period, available should be mentioned.
13. CMC/AMC of equipment after the warranty/Guarantee term is over the firm should mention the charges of CMC/AMC at least for the first three years from the principal.
14. The payment will be through invoice/credit bill system and by cheque only.
