**Tender Notice (Addendum)**

*In partial modification of the Tender Notice issued vide order No. CCCES/GL-1/553/2022 dated 05.09.2023, we are issuing the following.*

Sealed and competitive tenders are invited for the “**Establishment of Infrastructure for Rootstock Nursery**” at the Horticultural Development Farm, Malampuzha, Palakkad district as detailed below.

1	Clearing the site and levelling 30% slope land for beds of poly bagged seedlings (Three levels to minimize soil cutting and filling)	0.2 ha
2	Construction of shade house (50% of green net) Three adjacent arch shaped 8mx20m size GI structures constructed according to the slope at three levels. Each Arch shaped section should have centre height 2.4m and side height 2.1m with concrete re-enforced wind proof structure having 0.7m length foundation pipes. All sides cover with 50% of green net and entry door (Total size 24m x 20m for 30,000 poly bagged seedlings.	480m <sup>2</sup>
3	Shade house micro-Irrigation system (overhead micro sprinklers) distribution lines with accessories	480m <sup>2</sup>
4	Construction of potting mixture preparation hut shaped GI structure with 0.40mm GI sheet roof of size 12m x 8m. Centre height 3.6m and side height 2.1m with concrete re-enforced wind proof structure having 0.7m length foundation pipes. All sides cover with 50% of green net and entry door.	96m <sup>2</sup>

2. The sealed cover containing the tender should be super scribed “**Establishment of Infrastructure for Rootstock Nursery**” at the Horticultural Development Farm, Malampuzha, Palakkad and should be addressed to the DEAN, CCCES, K.A.U. P.O, Thrissur, Kerala-680 656.
3. Each tender should be accompanied by tender fee and an Earnest Money Deposit subject to minimum (EMD) of 2.5% of the total rupee equivalent cost of the quoted items (subject to maximum of Rs.50,000/-) by way of two crossed Demand Drafts separately for tender fee and EMD drawn in favour of DEAN, CCCES, Vellanikkara, KAU-680656 payable at the State Bank of India, KAU Campus, Vellanikkara. Late and incomplete tenders and tenders without EMD, tender fee and agreement will not be accepted.
4. The tender should be accompanied by an agreement in Kerala Stamp Paper worth Rs. 200/- (Rupees Two hundred only) and format can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the equipment or not according to the specification will entail cancellation of the tender.

The successful tender should execute an agreement in Kerala Stamp Paper worth Rs. 200/- (Rupees Two hundred only) and furnish a security deposit of 5% of the cost of construction quoted in the form of terms deposit/bank guarantee/demand draft drawn in favour of DEAN, CCCES, Vellanikkara, KAU-680656 at the State Bank of India, KAU Campus, Vellanikkara, when directed from this office. The format for the agreement can be downloaded from the above website. Firms who are exempted from payment of EMD should furnish copy of the currently valid certificate from the store Purchase Department, Govt. of Kerala.
6. The cost of the item / rate should be inclusive of all taxes.
7. The decision of the undersigned in finalizing the tenders shall be final and binding.
8. If any Bandh/strike/any unexpected holidays occur on the date of opening of tender, the tender will be opened at the same time on the next working day.
9. On receipt of work order, the contractor should complete the work at the earliest and work bill/ invoice in duplicate will be submitted for effecting payment. The payment will be effected only after satisfactory completion of work. GST, IT, KCWWF and other taxes if any at applicable rate will be deducted while effecting payment.
10. The DEAN, CCCES, Vellanikkara reserves the right to remove the defaulted name from the list of suppliers permanently or for a specific period.
11. List of similar works undertaken by the contractor should be provided.
12. The DEAN, CCCES, Vellanikkara has the right to accept or reject any or all of the offers without assigning any reason.
