Sealed tenders are invited in the prescribed form from competent firms/persons for the supply of the following works under various projects at the Cocoa Research Centre with specifications as detailed below:-

Transcriptome analysis of four samples of cocoa

Technical Specifications to the work

- Sample pick up from cocoa research centre, Vellanikkara, RNA isolation, cDNApreparation, preparation of Illumina compatible library.
- ➤ Sequencing: Raw data of minimum 120Mb per sample by sequencing on 150X2 Chemistry using Illumina platform.
- Analysis: Data quality control by filtering reads containing adapter or with low quality, Tag clustering analysis, Differential expression analysis of genes among the samples, annotation of differentially expressed genes to pathways and interpretation of results.
- ➤ Bioinformatics Analysis for Transcriptome/RNA Sequencing;
- Primary statistics report QA/QC results should be generated using FASTQC Tool(FastQC is a reliable quality control designed to help you verify the throughput sequence files and export the result in FastQ format.)
- Read statistics reports
- Alignment statistics report should be generated using HiSat Alignment Tool (Alignment program for mapping next generation sequencing)
- HISAT (hierarchial indexing for spliced alignment for transcripts) is a highly efficient system for aligning reads from RNA sequencing expriments.
- Differential Gene Expression Reports using DeSeq Tool(DESeq is an R package to analyse count data from high-throughput sequencing assays such as RNASeq and test for differential expression.)
- Transcript annotation results (Gene ontology and Pathway Analysis) using Uniprot/KEGG Database
- Under Gene ontology and pathway analysis the graphs for significantly enriched GO terms belonging all three classes (GO-MF, GO-BP, GO-CC) should be given. Similarly, for pathways graph has to be plotted for significantly enriched transcripts assigned to different pathways.
- Annotation is performed with frequently updated databases
- Transcript wise expression matrix across all samples using HTSeq Tool (tool to quantify gene expression)
- The tool is designed to deal with reads that align to or overlap with more than one feature. This tool is helps for accurate read count generation.

- Heatmap generation using RScript Tool (Rscript is the **R interpreter** which heps in the sequential execution of R commands in the script file)
- Standard figures and graphs including Principle component analysis (PCA plots), volcano plots, assembly length distribution, distance based clustering and Venn diagram should be given
- Bioinformatics Analysis support should be given
 - ➤ The company should have good experience/ record in conducting such experiments before with proof of publications, purchase order and satisfaction certificate given in writing.
