- Inking rollers must be coated with high-grade rubber, resistant to ink solvents and heat.
- Dampening rollers must be coated with hydrophilic rubber.
- Rubber-to-metal bonding must be flawless, and the surface texture must be uniform.
- Bearings must be durable and of standard quality ensuring smooth operation.

3. Quotation Details

The quotation must clearly mention:

- Unit Price
- GST
- Delivery Charges
- Any other applicable charges
- Total cost per item and overall cost for the complete supply

4. Delivery Period

The items must be delivered **within 15 days** from the date of acceptance of the quotation.

5. Warranty

Warranty details for each item, including rollers and bearings, must be clearly specified in the quotation.
