- 2. The sealed cover containing the tender documents should be superscribed as "Limited Tender for chemicals" along with the notification number and addressed to The Professor & Head, Rice Research Station, Vyttila.P.O, Ernakulam 682019.

- 3. Each tender should be accompanied by Tender Fee at 0.2 % and an Earnest Money Deposit (EMD) at 2.5 % of the total cost of item and remitted by a separate DD drawn in favour of the Associate Professor & Head, Rice Research Station, Vyttila". Late and incomplete tenders and tenders without EMD, tender fee and agreement will not be accepted. Firms who are exempted from payment of EMD should furnish copy of the currently valid certificate from the store Purchase Department, Govt. of Kerala.
- 4. The Tender should be accompanied by an agreement in Kerala Stamp paper worth Rs.200/- (Rupees Two hundred only) and format can be downloaded from the KAU website (www.kau.in). Withdrawal of tenders after its acceptance or failure to supply the item or not according to the specifications will entail cancellation of the tender.
- 5. The successful tenderer should execute an agreement in Kerala Stamp paper worth Rs.200/- (Rupees Two hundred only) and furnish a security deposit of 5% of cost of the item quoted in the form of demand draft drawn in favour of Associate Professor & Head, Rice Research Station, Vyttila payable at SBI, Vyttila.
