1. Sealed cover containing the quotation should be superscribed "**Quotation for Petrol operated Mini Chain Saw**" and addressed to the 'Professor and Head, Coconut Research Station, Balaramapuram' and reach the undersigned on or before 2.45 pm on **25.01.2023** and the same will be opened at **03:00 pm** on the same day at the chamber of the head of office in the presence of those quotationers or their representatives (with letter of authority from the concerned quotationers) who are present at that time.
2. Late and incomplete quotations will not be considered at any circumstances.
3. **The rate quoted should be inclusive of all taxes, transportation, loading & unloading, installation & fittings and other charges if any.**
4. Warranty should be clearly specified.
5. The firm should have service personal in Kerala preferably at Trivandrum. The firm should be nationally or internationally reputed and should be ISI/CE Certified.

6. The lowest rate offered as per the specifications will be accepted if reasonable.
7. Negotiations if any, will be conducted only with the person/firm who has offered the lowest price.
8. The item should be supplied and installed within 15 days on receipt of supply order issued.
9. The rules and regulations pertaining to Government quotations will be applicable to this quotation.
10. The equipment should be delivered and installed at the expenses of the successful bidder.
11. The firms/companies bidder should ensure onsite service support for the equipment.
12. All parts of the instrument, accessories, and supporting instruments should be covered under the warranty. During warrenty period, a minimum of 2 services have to be done.
13. The Quotationers should mention the email ID, GST and telephone/mobile number of the firm on the Quotation. If GST number is not issued, the statement for the same may be submitted separately (showing the turn over is below the prescribed criteria).
