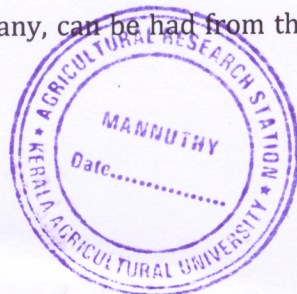

Sealed tenders are invited from persons/firms who are willing to supply good quality bare rooted mango seedlings [approximately 200000 numbers] to this station

TERMS AND CONDITIONS

- 1 The tender form can be downloaded from the website <http://www.kau.in/tenders>
- 2 The cost of tender form [tender fee] is Rs 800/- + 18 % GST [total Rs 944/-; non refundable]. The tender fee can be paid by way of cash/Demand Draft [two separate DDs for tender fee and GST] in favour of **the Professor & Head, Agricultural Research Station, Mannuthy**, payable at the **State Bank of India, Ollukara Branch [Branch Code 70210]** which is to be enclosed along with the tender form
- 3 An amount of Rs 4000/- has to be remitted as Earned Money Deposit [refundable]. EMD can be paid by way of cash/Demand Draft in favour of **the Professor & Head, Agricultural Research Station, Mannuthy**, payable at the **State Bank of India, Ollukara Branch [Branch Code 70210]** which is to be enclosed along with the tender form submitted
- 4 An agreement has to be executed on Kerala Stamp paper for Rs 200/-. The form of agreement can be downloaded from the Related Document Window in the website <http://www.kau.in/tenders>
- 5 The offer should clearly indicate the amount for the item and taxes, customs and excise duty, transportation, packing, forwarding and any other charges, if any, separately
- 6 The sealed cover containing tender documents should be superscribed as **Supply of bare rooted mango seedlings** and reach the same to the undersigned [**The Professor & Head, Agricultural Research Station, Mannuthy, Thrissur - 680651, Kerala**] on or before **03:00 pm on 19/05/2023**. The tender documents will be opened at 03:30 pm on the same day in the presence of the tenderers present then and there. Tenders received late or incomplete in any respect will be summarily rejected without any further notice and the decision of the undersigned on such matters will be final
- 7 Successful tenderer will have to execute an agreement and remit security deposit @ 4% of the value of the items ordered, in cash or by way of Demand Draft or Fixed Deposit Receipt
