REVISED TENDER NOTICE

Sealed tenders on competitive basis are invited for the supply of chain link according to the following terms and conditions detailed below.

Specifications:

CHAIN LINK (GI)

- Mesh : 2" x 2"
- Wire Diameter : 3 mm
- Height : 4' , 5' , 6'
- Rate /Kg have to be quoted.
- Length/Kg in meters have to be indicated.
- Quantity required (Approx.): 4' - 200 m , 5' - 200 m , 6' - 200m

ANGULAR POLE (GI)

- 1.5 m length with basal crossing (35 x35 x6 mm)
- 1.8 m length with basal crossing (35 x35 x6 mm)
- 2.15 m length with basal crossing (35x35x6mm)

Terms and condition:-

1. Tender should be submitted in the prescribed form which can be downloaded from the web link www.rarsptb.kau.in/tenders. The cost of tender form is Rs. 600/- + 18% GST (ie. Total amount of Rs. 708/-) which will be accepted by way of Demand Draft drawn in favour of "Associate Director of Research, Regional Agricultural Research Station, Pattambi" payable at State Bank of India, Pattambi and should be send separately along with the tender

2. The tender should be accompanied by an agreement in Kerala stamp paper worth Rs. 200/- (Rupees Two Hundred only) ,the format of which can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the items or not according to the specification will entail cancellation of tender.
3. EMD amount of Rs. 3000/- should be remitted along with the tender cost of Rs. 708/- by two separate Demand Drafts drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi payable at State Bank of India, Pattambi. No other Demand Draft will be entertained.
4. The sealed cover containing the tender should be super scribed as "Revised Tender for the supply chain link and supporting poles as per tender notice No. D3-7124/2022 dtd 14.02.2023
5. Tenders will be accepted up to 2 pm on 27.02.2023. Tenders received after the stipulated time will not be accepted.
6. Tenderers claiming exemption from paying EMD should produce necessary evidence/ documents in support of their request
7. Tenders will be opened at 2.30 pm on the same day at the presence of those bidders who are present at that time.
8. The bidder of the accepted tender should enter into an agreement with the Associate Director of Research, Regional Agricultural Research Station, Pattambi on Kerala stamp paper worth Rs. 200/-. The format of the agreement is available in the web link www.rarsptb.kau.in/tenders. He should also submit a security deposit equal to 5% of the cost of above mentioned items in the form of Term Deposit/Bank Guarantee/Demand Draft drawn in favour of Associate Director of Research, Pattambi payable at State Bank of India, Pattambi.
9. Material should be supplied in accordance with the supply order issued from this office and installed accordingly.
10. Payment of cost of the materials will be made by invoice cum cheque basis.
11. Any failure on the part of supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
12. All other technical and commercial terms and conditions as per the code rules in force in Kerala State will be applicable in this case also.

Special Conditions.

1. Tenders insisting payment in advance either full or in part for releasing the documents through bank are liable to be rejected.
2. The undersigned reserves the authority to accept or reject any or all of the offers for the above mentioned items without assigning any reason whatsoever.
