- The envelope containing the tender should be superscripted as "Tender for Installing Wifi Connection" and should be addressed to the Dean, College of Agriculture, Padanakkad (P.O.), Kasaragod-671 314
- 4. The successful tenderer should execute an agreement in Kerala stamp paper worth Rs.200/- and furnish a Security Deposit of 5% of the cost of the items quoted in the form of Term Deposit /Bank Guarantee/Demand Draft drawn in favour of the Dean, College of Agriculture, Padanakkad payable at the State Bank of India, Nileshwar Town Branch (IFSC Code: SBIN0010675) when directed from this office.
