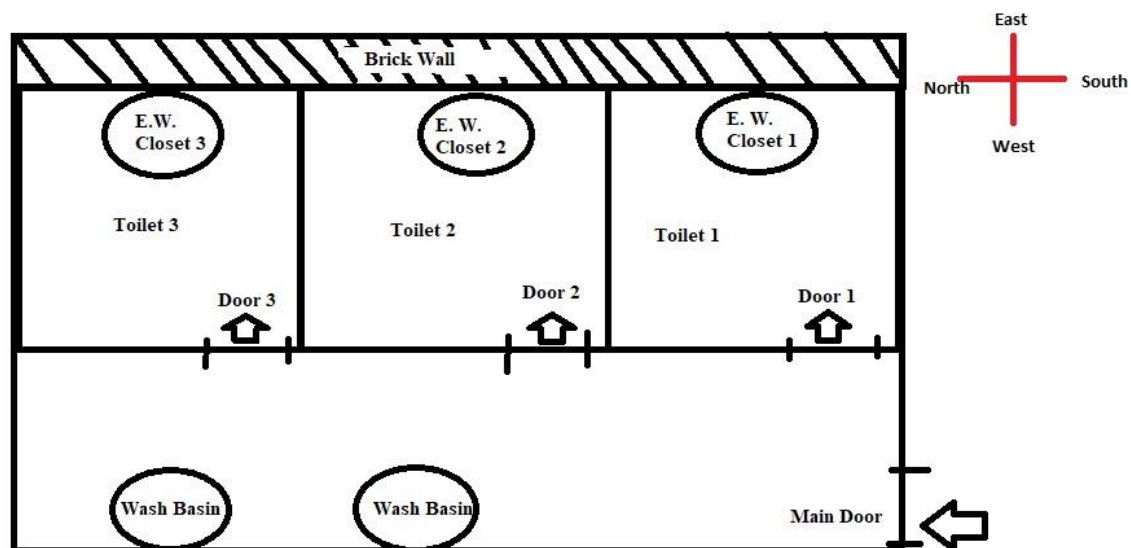

### Terms and Conditions

1. The tender should be submitted in the prescribed forms which can be downloaded from the website: [www.kau.in/tenders](http://www.kau.in/tenders).
2. The envelope containing the tender should be superscribed for the “**Construction of new ladies’ toilets at first floor at CCC&ES**” and should be addressed to the DEAN, College of Climate Change and Environmental Science, K.A.U. Post, Thrissur, Kerala – 680656.

3. Each tender should be accompanied by an Earnest Money Deposit (EMD) of 2.5% of the total cost of the quoted work and Tender Cost as mentioned above by way of Demand Drafts separately drawn in favor of the DEAN, CCC&ES, Vellanikkara payable at the State Bank of India, KAU Campus (Branch Code 70670) along with the Tender Agreement. Late and incomplete tenders and tender without EMD and agreement will not be accepted.
4. The successful tenderer should execute an agreement in Kerala Stamp paper worth Rs.200 (Rupees Two Hundred only) at the time of supply of items and furnish a security deposit of 5% of the cost of tendered work in the form of term deposit/bank guarantee/demand draft drawn in favour of DEAN, CCC&ES, Vellanikkara payable at the State Bank of India, KAU campus (Branch Code 70670). Firms who are exempted from payment of EMD should furnish copy of the currently valid certificate from the Store Purchase Department, Govt. of Kerala. The format can be downloaded from the above website.
5. The decision of the undersigned in finalizing the tenders shall be final and binding.
6. If any Bandh/Strike/any unexpected holidays occur on the date of opening of tender, the tender will be opened at the same time on the next working day.
7. On acceptance the work order will be placed and should be completed within 45 days from the date of receipt of work order. The invoice in duplicate should be addressed to the DEAN, CCC&ES, Vellanikkara. The payment will be effected only after the satisfactory completion of works. The DEAN, CCC&ES, Vellanikkara reserves the right to remove the defaulted name from the list of contractors permanently or for a specific period.
8. Tenders insisting payment in advance either full or part for releasing the documents through bank are liable for rejection.
9. The EMD/Security Deposits furnished will be forfeited in case the contract is not fulfilled as per the term and conditions mentioned in the tender notice and agreement.
10. The Dean, CCC&ES, Vellanikkara has the right to accept or reject any or all of the offers without assigning any reason.
11. All the rules and regulations applicable to Government Tenders will be applicable to this tender also.
12. Bank account credentials (Name & branch, Account No. and IFSC Code) to be furnished in the invoice for effecting payment.
